

AMENDMENT

It is agreed by and between the State of Vermont, Department of Vermont Health Access (hereinafter called "State") and Custom Courier, with a principal place of business in Burlington, VT 05402 (hereinafter called "Contractor") that the contract originally entered into on November 1, 2008 is hereby amended as follows:

1. By deleting "Parties", "Maximum Amount", and "Contract Term" (sections #1, #3, and #4) on Page 1 of 18, and substituting in lieu thereof the following:

1. **Parties** This is a contract for personal services between the State of Vermont, **Department of Vermont Health Access** (hereafter called "State"), and (Custom Courier)(hereafter called "Contractor"). Contractor's form of business is Courier Service. If the contractor does not have a Business Account Number, it is the contractor's responsibility to contact the Vermont Department of Taxes to determine, if by law, the contractor is required to have a Vermont Department Taxes Business Account Number.
3. **Maximum Amount** In consideration of services to be performed by the Contractor, the State agrees to pay the Contractor, per payment provisions specified in Attachment B, a sum not to exceed **\$42,000.00**.
4. **Contract Term** The period of contractor's performance shall begin on **November 1, 2008** and end on **October 31, 2011**. By mutual agreement, this contract may be extended for a period or periods totaling up to two additional years.
