

AMENDMENT

It is agreed by and between the State of Vermont, Department of Vermont Health Access (hereafter called the "State") and Theresa Fortner (hereafter called the "Contractor") that the contract on the subject of **Expansion and Quality Improvement Program Faciliator**, effective November 1, 2011, is hereby amended effective upon execution, as follows:

The amendment to this contract will effect and be applicable to all work related to this contract.

By deleting on page 11 of x20, Section 3 Attachment D and substituting in lieu thereof the following Attachment D:

ATTACHMENT D

MODIFICATION OF CUSTOMARY PROVISIONS
OF
ATTACHMENT C OR ATTACHMENT F

1. The insurance requirements contained in Attachment C, Section 7 are hereby modified:

Under the *Automotive Liability*: section, delete the following language:

Automotive Liability: The Party shall carry automotive liability insurance covering all motor vehicles, including hired and non-owned coverage, used in connection with the Agreement. Limits of coverage shall not be less than: \$1,000,000 combined single limit.

Party shall name the State of Vermont and its officers and employees as additional insureds for liability arising out of this Agreement.

And add the following language

Automotive Liability: The Party shall carry automotive liability insurance covering all motor vehicles, including hired and non-owned coverage, used in connection with the Agreement. Limits of coverage shall not be less than:

Bodily Injury Liability: \$300,000/\$300,000

Property Damage: \$100,000

Party shall name the State of Vermont and its officers and employees as interested parties for liability arising out of this Agreement.

Under the *General Liability and Property Damage*: section, delete the following language:

Party shall name the State of Vermont and its officers and employees as additional insureds for liability arising out of this Agreement.

2. Requirements of other Sections in Attachment C are hereby modified:


3. Requirements of Sections in Attachment F are hereby modified:

4. Reasons for Modifications: Contractor's vehicle insurance carrier can not write a policy to include the State of Vermont as additionally insured, but will write a policy to include the State as an interested party. Contractor's Auto insurance coverage limits were discussed with State Risk Manager, Bill Duchac who states that listing the State as an interested party and reducing the liability limits as described above is acceptable and "...auto is approved without the need to pursue additional insured status." It is also agreed that the requirement to list the State as additionally insured on the contractor's General Liability insurance certificate is also waved.


