

**AMENDMENT**

It is agreed by and between the State of Vermont, Department of Vermont Health Access (hereinafter called "State") and Goold Health Systems, Inc. (GHS), an Emdeon company, with a principal place of business at 45 Commerce Drive, Suite 5, PO Box 1090, Augusta, Maine 04332-1090 (hereinafter called "Contractor") that the personal services contract generally on the subject matter of procurement services for Medicaid supplemental drug rebates and other Medicaid pharmacy benefit rebates, entered into May 1, 2011, is hereby amended, effective March 31, 2014, as follows:

- 1. By deleting on page 1 of 82 of the base agreement and as previously amended, Section 3 (Maximum Amount) and substituting in lieu thereof the following Section 3:**

- 3. Maximum Amount.** In consideration of the services to be performed by Contractor, the State agrees to pay Contractor, in accordance with the payment provisions specified in Attachment B, a sum not to exceed \$580,949.50.

- 2. By deleting on page 1 of 82 of the base agreement and as previously amended, Section 4 (Contract Term) and substituting in lieu thereof the following Section 4:**

- 4. Contract Term.** The period of Contractor's performance shall begin on May 1, 2011 and end on March 31, 2015.

- 3. By deleting on page 29 of 82 of the base agreement, the last paragraph of Attachment B, Section III, Payments for Collective Services, of Attachment B (Payment Provisions) and substituting in lieu thereof there the following paragraph:**

Under this Contract, the total maximum amount payable for collective services for the two (2) contract years, base Contract period and two (2) extension contract years, is \$580,949.50.

- 4. By deleting pages 37-42 of 82 of the base agreement, Attachment E (Business Associate Agreement) revised 12/10/10. The Specifications of Work to be Performed as described in Attachment A of this Contract do not require the Contractor to have access to Medicaid beneficiary identifiers and their protected health information, pharmacy benefit prescribers, dispensing pharmacies or other enrolled Medicaid service providers. Should the Specifications of Work related to such personal beneficiary information change in the course of this contract, a contract amendment will be executed and an Attachment E (Business Associate Agreement) will be required.**

This amendment consists of 1 page. Except as modified by the above amendment, all provisions of the original contract as previously amended shall remain unchanged and in full force and effect.
