

MEMORANDUM OF AGREEMENT
BETWEEN THE DEPARTMENT OF VERMONT HEALTH ACCESS AND THE
GREEN MOUNTAIN CARE BOARD

The Department of Vermont Health Access (DVHA) and the Green Mountain Care Board (GMCB) will collaborate on specific deliverables in the contract managed by the GMCB with Onpoint Health Data for the term spanning July 1, 2014 through June 30, 2015 for data collection, processing, testing, consolidation, and data warehouse management collectively referred to as the Vermont Healthcare Claims Uniform Reporting and Evaluation System (VHCURES). Per this MOU and as requested by the commissioner of DVHA, the GMCB VHCURES contract includes ongoing integration and management of eligibility and claims data for Vermont Medicaid eligibles starting with an incurred claims date of January 2007 and moving forward with monthly data feeds. DVHA agrees to transfer a total of \$126,000.00 for the current MOU term towards the continued integration of Medicaid eligibility and medical and pharmacy claims data into the VHCURES data warehouse.

Purpose

In 2010 the Dept. of Financial Regulation's (formally BISHCA) contract with Onpoint Health Data was amended to include the integration and management of Medicaid eligibility and claims data. The amendment to extend the contract was requested by the commissioners of DFR and DVHA as being integral to the data infrastructure required to support the analytical and reporting needs of the State of Vermont. In July of 2013 the management of this contract moved from DFR to the GMCB. The ongoing integration of Medicaid eligibility and claims data with the commercial insurer data supports the State's ability to evaluate health care utilization, spending, and performance on a broader population basis and on a comparative basis for each insurer type.

DVHA agrees to transfer up to \$126,000.00 to GMCB for the purpose of supporting the continuous integration of Medicaid data into VHCURES. GMCB staff will manage the contract that includes these specific deliverables within the scope of-work. DVHA will work with both GMCB and their vendor to provide technical assistance as necessary.

Term of Agreement

This MOU will be in effect upon signature by the Commissioner of DVHA and will end on June 30, 2015. This MOU shall be amended as necessary.

Payment Terms

- GMCB agrees to submit quarterly invoices to DVHA detailing a report of expenditure by the 25th day of the month following each fiscal quarter for expenses relating to the included budget. Expenses incurred from July 1, 2014 through June 30, 2015 directly relating to GMCB's contract# 16420 for ongoing integration of Medicaid eligibility and claims data into VHCURES.
- Based on the quarterly expenditure reports, DVHA will initiate an interdepartmental transfer to reimburse GMCB for these expenditures by the 30th day after receipt of the report. Notification of the transfer will be sent via email to Jason Pinard GMCB business office @jason.pinard@state.vt.us.

Funding

Funding will come from DVHA separate and above Global Commitment funds currently obligated to HCA.
