EVV IS REQUIRED BY LAW IN VERMONT

Electronic Visit Verification a telephone and online system that records information about personal care visits for those on Medicaid.

EVV IS REQUIRED

If you manage services in these Medicaid programs

- ◆ **Children's Personal Care**
- ◆ **Choices for Care**
- ◆ **Attendant Services**
- ◆ **Brain Injury**

EVV is required every time a service is provided, unless services are provided entirely outside of the home or if the care provider lives in the home with the care recipient.

USE EVV TO RECORD ALL VISITS

EVV provides an easy way to record visit start and end times. You can choose to use EVV for all your services, even those that occur entirely outside of the home.

EVV will save you time.

IF YOU DON'T USE EVV

In the coming months, program funds cannot be used to pay for services if you and your care provider don't use EVV.

EVV IN ACTION

Care providers can use an EVV app or landline phone to record their start and end times. The EVV app is available free of charge and can be downloaded to a smartphone or tablet. The app can record a visit even without a cell or Wi-Fi signal.

You will use an EVV Portal Website to review and correct these recorded visits. If you do not have a computer, call our **EVV Support Team at (800) 798-1658.**
