STATE OF VERMONT
CONTRACT AMENDMENT

It is hereby agreed by and between the State of Vermont, Department of Vermont Health Access (the "State") and Change Healthcare Technologies LLC., with a principal place of business in Alpharetta, GA (the "Contractor") that the Contract between them originally dated as of December 10, 2017, Contract # 36706, as amended to date, (the "Contract") is hereby amended as follows:

- I. **Maximum Amount.** The maximum amount payable under the Contract, wherever such reference appears in the Contract, shall be changed from \$911,107.93 to \$1,089,005.40, representing an increase of \$177,897.47.
- II. **Contract Term.** The Contract end date, wherever such reference appears in the Contract, shall be changed from December 9, 2022, to December 9, 2023.
- III. **Attachment A, Scope of Services.** The Scope of Services is amended as follows:

Exhibit A-1 to Attachment B Fees Summary, Payment Schedule and Administration Fees Summary on Page thirty-five of the base Contract is hereby amended by the addition of the following requirements:

Optional Renewal Terms for the Contract year six:

\$169,882.63 due on the fifth anniversary of the OF Effective Date.
