

STATE OF VERMONT
CONTRACT AMENDMENT

It is hereby agreed by and between the State of Vermont, Department of Vermont Health Access (the "State") and Planned Parenthood of Northern New England, with a principal place of business in Burlington, Vermont (the "Contractor") that the Contract # 37677 between the Parties originally dated February 1, 2019, and as amended to date, (the "Contract") is hereby amended as follows:

- I. **Contract Term.** The Contract end date, wherever such reference appears in the Contract, shall be changed from January 31, 2022 to January 31, 2023.

Section 7. Subcontractor Requirements is hereby deleted in its entirety and replaced as set forth below.

Upon receipt of the Subcontractor Compliance Form, the State shall review and respond within five (5) business days. Under no circumstance shall Contractor enter into a sub-agreement without prior authorization from the State. Contractor shall submit the Subcontractor Compliance Form to:
