






• Pre and Post Pandemic: Length of time to Obtain a Complex Wheelchair







The graphs do not include the days between physician referral and therapist evaluation because that data was not collected until 2020. In 2021, it took 53 days to schedule a therapist's wheelchair evaluation, for a complete total of **205** days between doctor's order and date of delivery. Vendors, therapists, and DVHA staff all agree that under **120** days should be sufficient.

Comparison: In 2021, it took LESS TIME for vendors to request authorization after the evaluation, which may reflect the new vendor office staff that has had difficulty submitting the correct information and therapists who are new to the wheelchair evaluation process.

In 2021, it took MORE TIME from authorization until equipment provision, which may reflect the shortage of delivery staff and supply chain issues.

In 2021, the longer time for authorization at DVHA reflects DVHA's need to obtain the necessary documentation needed to complete the review given new therapists and vendor staff.



- DVHA recognizes that obtaining Wheel Chairs and Parts is a challenge
- We continue to work together to meet these challenges and work on solutions
- As vendor issues continue, supply chains issues continue DVHA will continue to work to assist our members in finding the needed services.

Points to remember

- If Medicaid is Secondary or Tertiary insurance Members need to work with Primary insurance first
