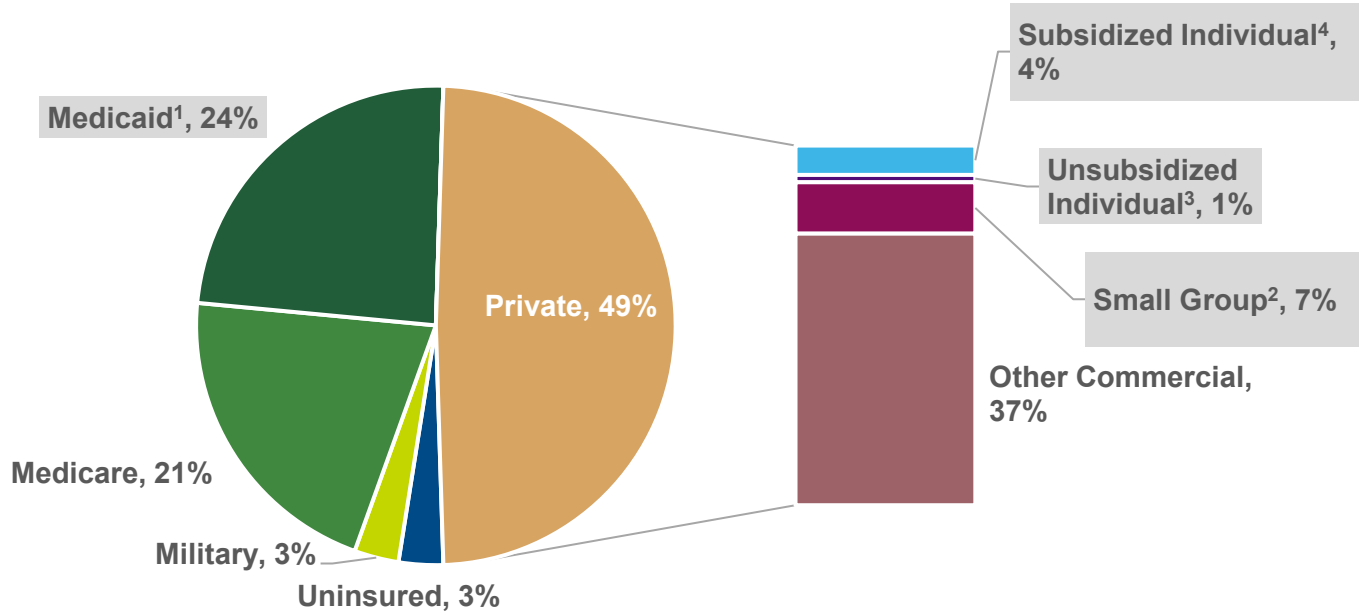


HEALTH INSURANCE IN VERMONT*

⁴ DVHA uses the tax-based measure of income, Modified Adjusted Gross Income (MAGI), to determine eligibility for Medicaid for Children and Adults and financial help for qualified health plans in accordance with the Affordable Care Act. Medicaid for the Aged, Blind, and Disabled, Pharmacy Assistance, and Choices for Care use eligibility standards (Non-MAGI) that existed prior to the Affordable Care Act.

⁵ If members do not provide financial information, they cannot be determined eligible for advanced payments of premium tax credits (APTC). However, as long as they enroll through Vermont Health Connect, they may still receive premium tax credits when they file their federal taxes.

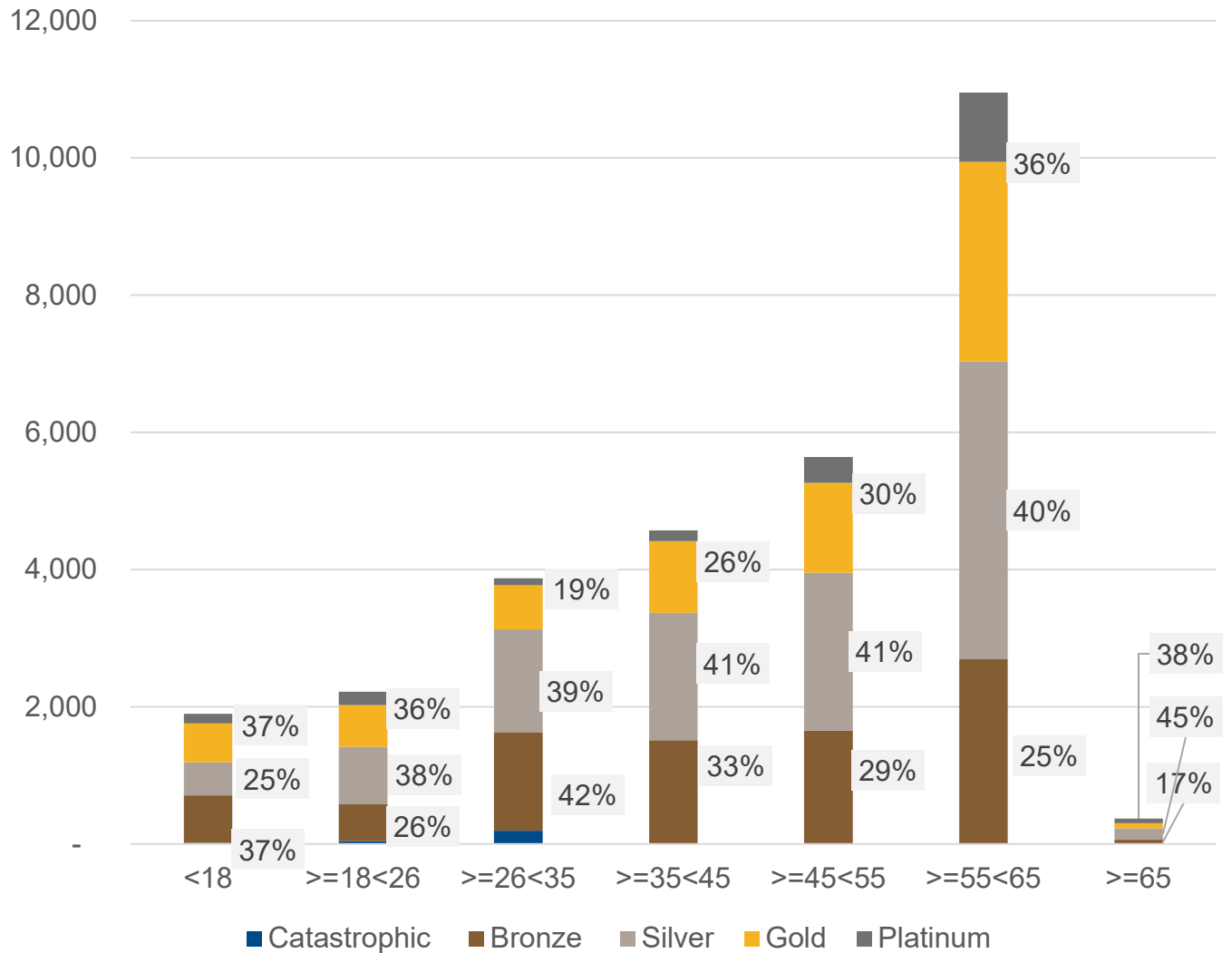

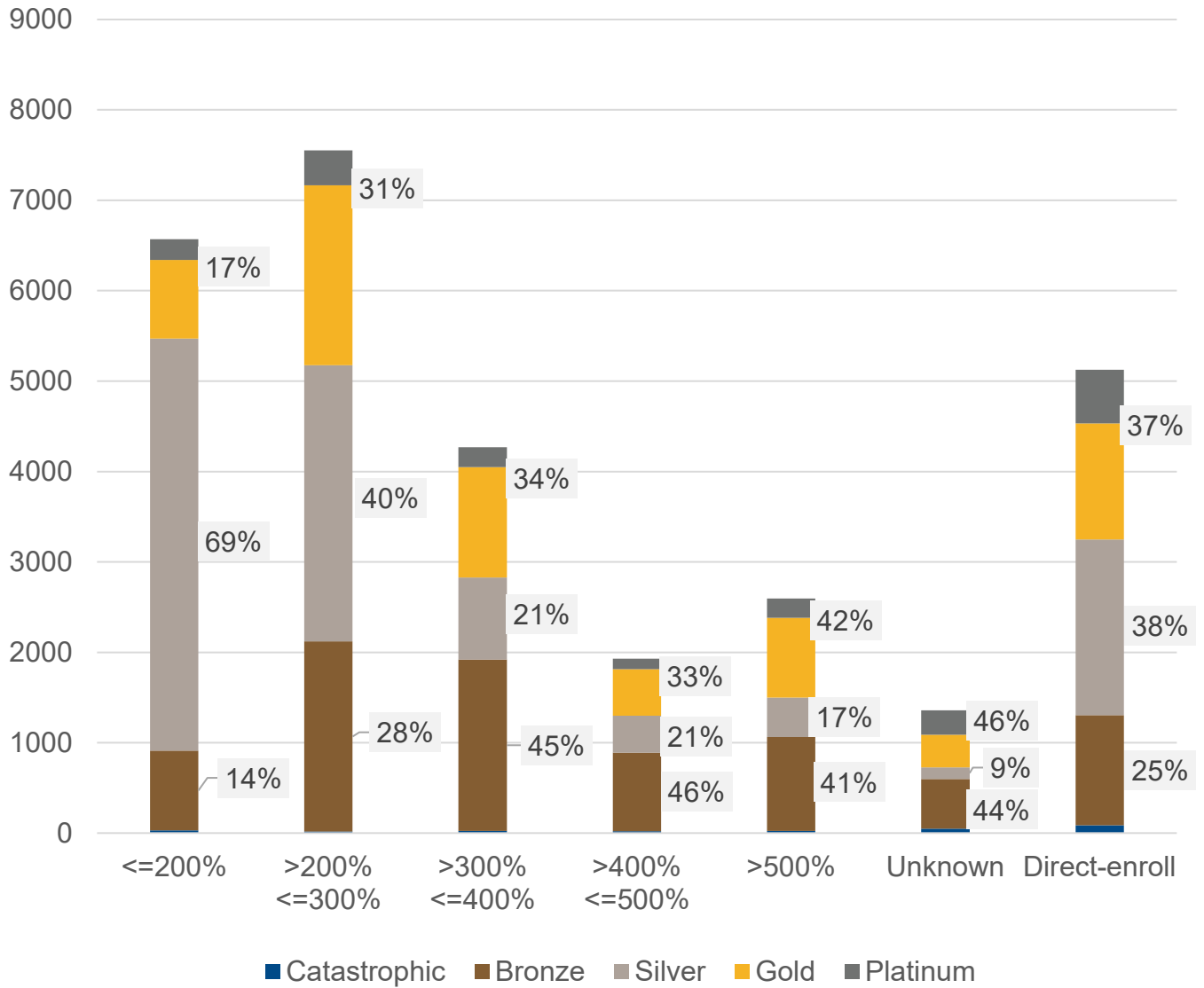

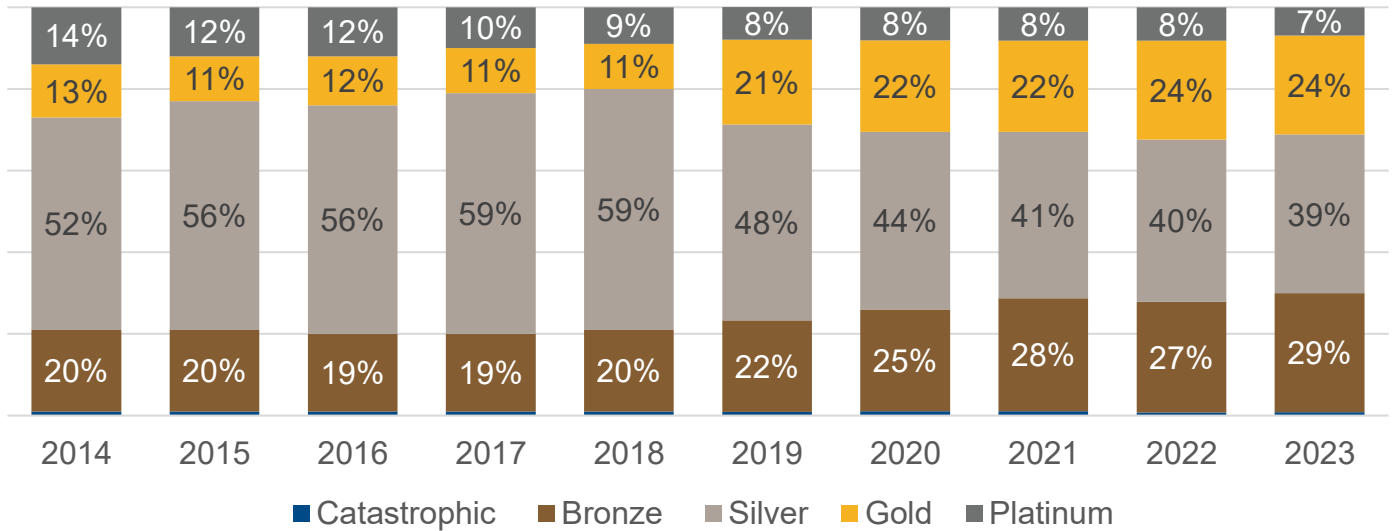
2023 Enrollment by Age

 % enrolled in bronze/cat v. silver v. gold/plat

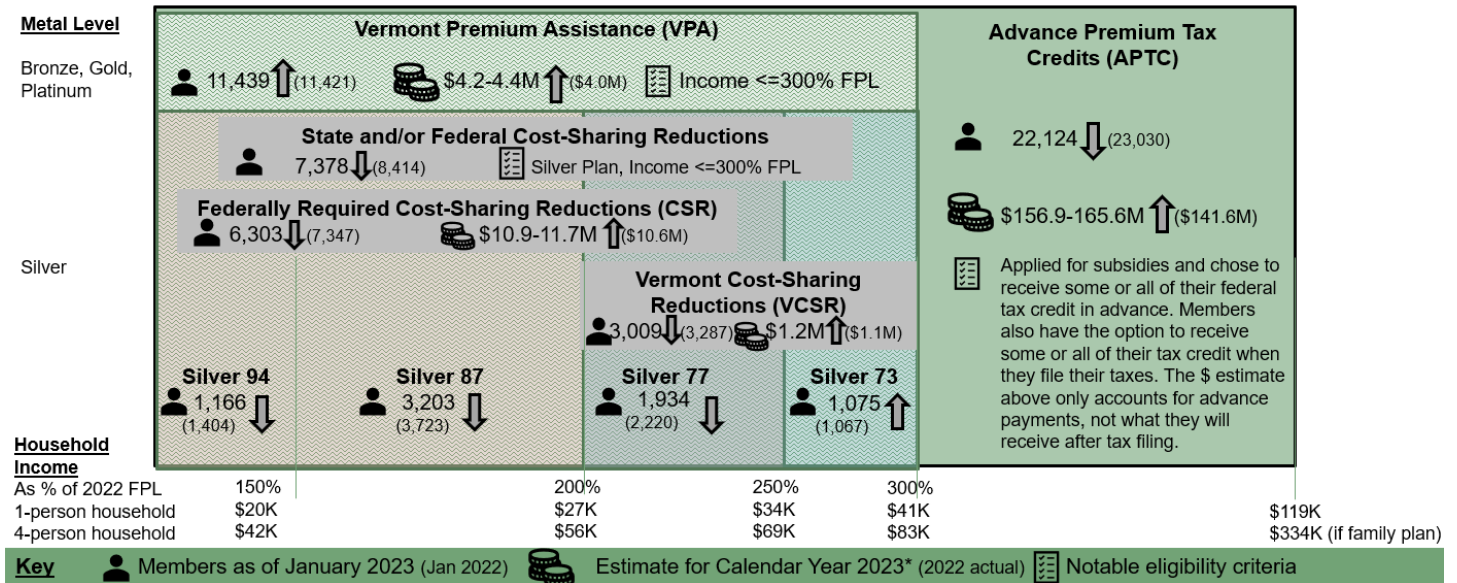


Metal Level Distribution by Year - Individual Market



A CLOSER LOOK: INDIVIDUALS IN QUALIFIED HEALTH PLANS WITH SUBSIDIES

As of January 2023, just over three-quarters of Vermonters in the individual market received federal premium tax credits to lower their monthly insurance costs. Many also received financial help to further reduce premium and out-of-pocket costs from the State and/or through federally required benefits. To qualify, they can't have another offer of affordable coverage, must enroll in a metal level plan, and must meet income guidelines.



*Estimates of total 2023 subsidies are based on June enrollment figures, typical annual attrition rates, and expected mid-year enrollment due to the Medicaid continuous coverage requirement ending. These estimates are presented as a range due to anticipated migration from Medicaid over the course of the year.
