

AMENDMENT

It is hereby agreed by and between the Parties, **State of Vermont, Department of Vermont Health Access** (hereinafter called "State") and **Gainwell Technologies LLC** (the "Contractor") that Contract #35485A originally dated as of January 1, 2017, as amended to date, is hereby amended effective February 1, 2021 as follows:

- I. The entity name of the "Contractor" shall change from "DXC MS LLC" to "Gainwell Technologies LLC" effective February 1, 2021. All references to DXC MS LLC are replaced with references to Gainwell Technologies LLC.**
- II. Contractor has submitted new W9 information to the State in connection with all billing.**
- III. Contractor hereby certifies that all insurance certificates previously provided to the State remain true and correct and describe insurance policies currently in effect and shall provide updated certificates with Contractor's new name information when any changes to insurance occur.**

Taxes Due to the State. Contractor further certifies under the pains and penalties of perjury that, as of the date this contract amendment is signed, the Contractor is in good standing with respect to, or in full compliance with a plan to pay, any and all taxes due the State of Vermont.

Child Support (Applicable to natural persons only; not applicable to corporations, partnerships or LLCs). Contractor is under no obligation to pay child support or is in good standing with respect to or in full compliance with a plan to pay any and all child support payable under a support order as of the date of this amendment.

Certification Regarding Suspension or Debarment. Contractor certifies under the pains and penalties of perjury that, as of the date this contract amendment is signed, neither Contractor nor Contractor's principals (officers, directors, owners, or partners) are presently debarred, suspended, proposed for debarment, declared ineligible or excluded from participation in federal programs, or programs supported in whole or in part by federal funds.

Contractor further certifies under pains and penalties of perjury that, as of the date that this contract amendment is signed, Contractor is not presently debarred, suspended, nor named on the State's debarment list at: <http://bgs.vermont.gov/purchasing-contracting/debarment>.

Sole Source Contractor Certification. This Contract results from a "sole source" procurement under State of Vermont Administrative Bulletin 3.5 process and Contractor hereby certifies that it is and will remain in compliance with the campaign contribution restrictions under 17 V.S.A. § 2950.

This document consists of 2 pages. Except as modified by this Amendment No. 6, all provisions of the Contract remain in full force and effect.
