STATE OF VERMONT  
CONTRACT AMENDMENT

It is hereby agreed by and between the State of Vermont, Department of Vermont Health Access (the "State") and Northwest Medical Surgical Associates, with a principal place of business in St. Albans, Vermont (the "Contractor") that the contract between them originally dated as of January 1, 2018, Contract # 35398, as amended to date, (the "Contract") is hereby amended as follows:

- I. Maximum Amount.** The maximum amount payable under the Contract, wherever such reference appears in the Contract, shall be changed from \$388,000.00 to \$418,000.00, representing an increase of \$30,000.00.
- II. Attachment B, Payment Provisions.** The payment provisions are amended as follows:
- a. Section 10 (Budget) is amended by the addition of the following requirements:
