## Microsoft Teams information

After receiving feedback from members during the last two Advisory Committee meetings that indicated a new platform may improve the virtual connectivity through enhanced video options for member participation, we will be testing the use of the Microsoft Teams platform for the August Advisory Committee. While members may still call into the meeting using dial-in information, this offers enhanced options for video conferencing. Microsoft Teams displays up to 9 meeting participants on the screen at one time. Importantly, Microsoft Teams offers closed captioning; Zack Goss indicates that the accuracy of the closed captioning feature has been highly accurate in initial tests.
