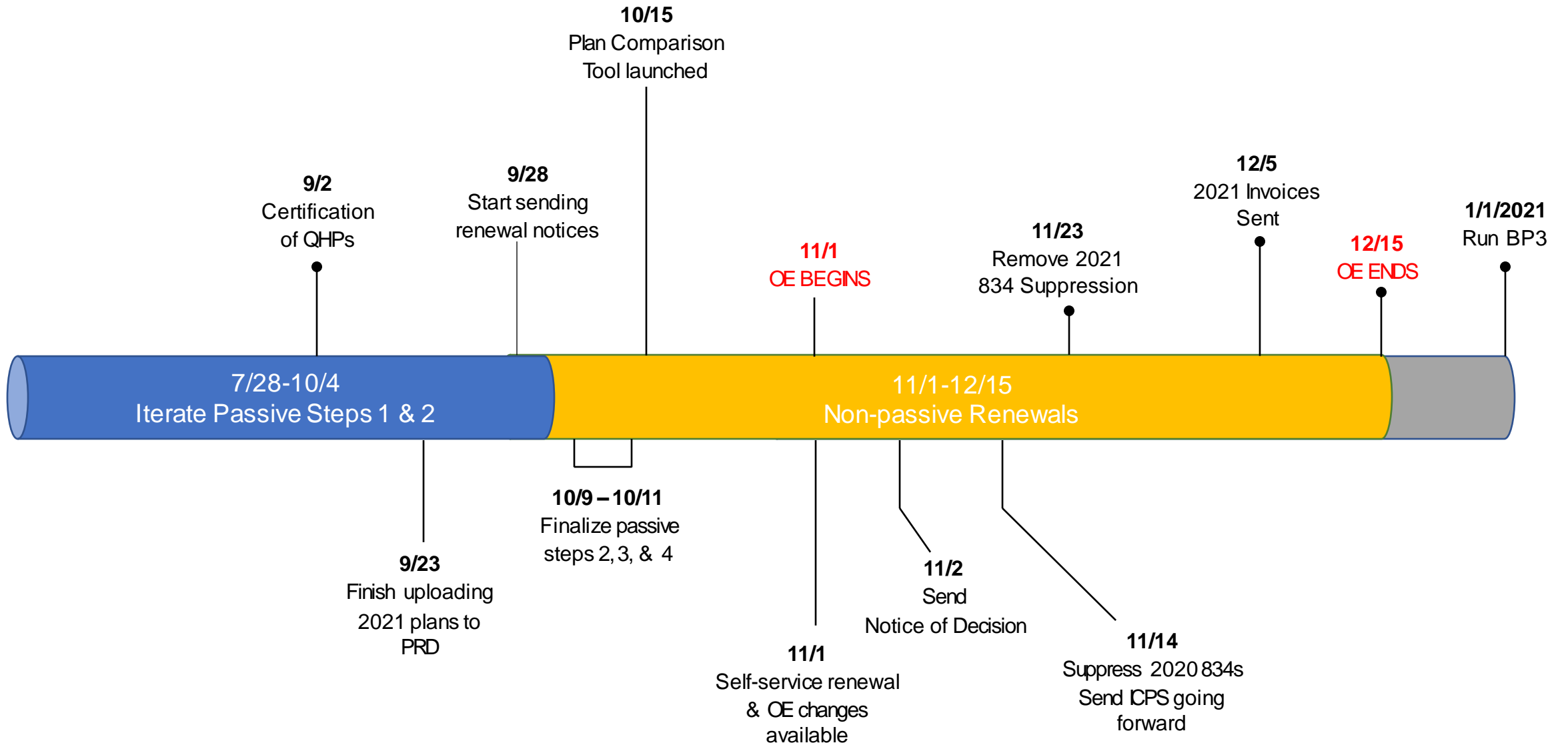

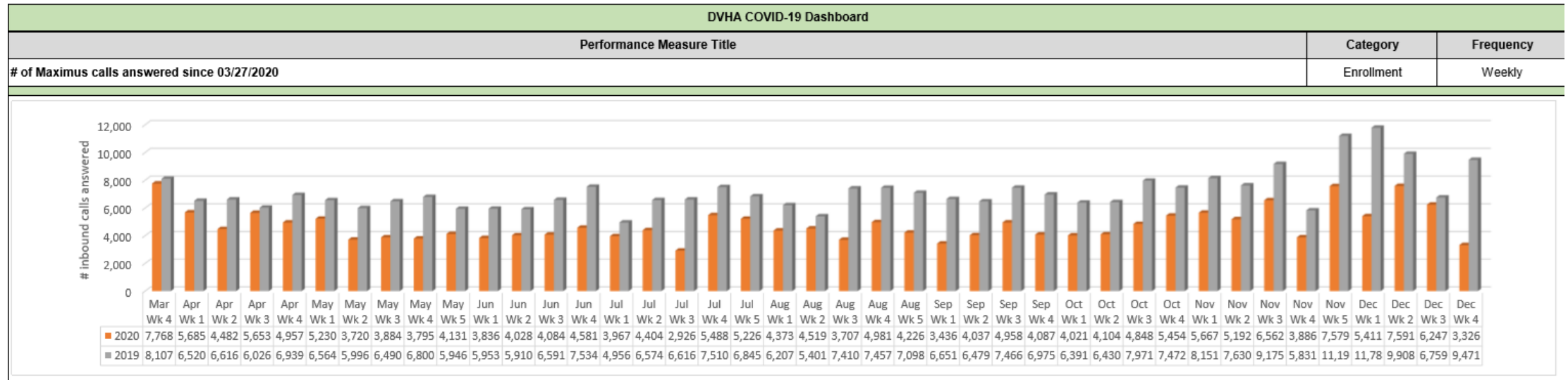

# 2021 Open Enrollment Wrap Up

- QHP Renewal population: **~18,000**
- Passive file success rate: **99.49%**
- # of HHs switched plans for 2021: **251**
- 834 Files transmitted to issuers:
  - ❖ BCBS: **7,871**
  - ❖ MVP: **9,294**
  - ❖ NEDD: **1,453**
- 492 households experienced a loss of APTC
