MSP (Medicaid Savings Program) Eligibility  Mike Fisher, Chief Health Care Advocate, Vermont Legal Aid Emma Zavez, Consumer Research & Health Policy Analyst, VT Legal Aid	<ul> <li>communicate in plain language. Stacy noted that they have increased training to support assisters in being able to present the information in an accessible way.</li> <li>Stacy stated that she would like to go talk to organizations that are serving their communities and asked members to share any that come to mind or local organizations that are connected to their respective communities.</li> <li>Discussion ensued.</li> <li>Stacy shared that she would appreciate connections and introductions with people as well as being invited to present or table at events where potential partner organizations will be.</li> <li>Mike explained that the problem that many low-income Vermonters on Medicare can't afford the health care services they need.</li> <li>He gave an overview of the Medicare costs in 2024.</li> <li>Mike explained that a lot of effort has been put into service those under 65; however, access to affordable coverage drops for those over 65 and/or are disabled.</li> <li>He noted that some states have eligibility expansions.</li> <li>Vermont Legal Aid put forward two bills in legislature that were introduced last year – H.118/S.61.</li> <li>It was noted by a MEAC member that two issues are that people can no longer earn an income and be eligible for Medicaid after age 65.</li> <li>Goal is not to change the coverage, but that the state funds full coverage of those benefits.</li> <li>Mike proposed a motion of support for increasing the eligibility</li> </ul>	
	threshold for the MSPs and asked that the committee have an opportunity to vote on it next month.
