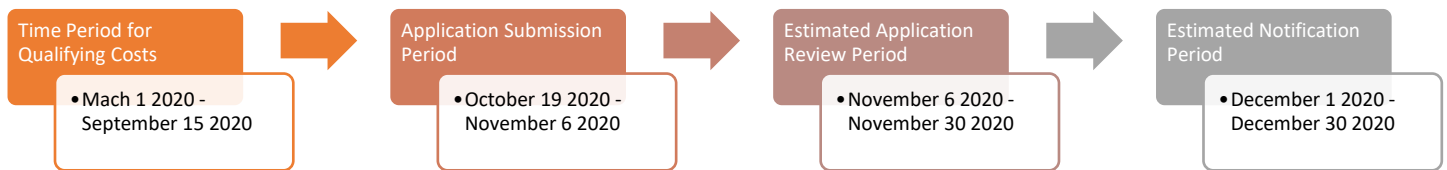

Review Process

Applicant Validation

During the review process, AHS will verify any/all the following information (as applicable):

- Eligibility of the applicant (e.g., domiciled in Vermont, open before Feb 2020, etc.)
- W-9 accuracy
- ACO fixed payments and status of participation
- Economic Recovery Grants received from the State of Vermont (e.g., Round One HCS grant awards, ACCD grant award, etc.)
- Federal Funds received
- FEMA eligibility

Award Calculation

An applicant must have qualifying COVID-19-related revenue losses and/or eligible COVID-19-related expenses that have not already been covered by another source to receive an award to demonstrate an unmet need that would result in a HCS grant award. The HCS grant application calculates the award amount based on the application inputs (as verified by the supporting documentation) as follows:

$$\text{Qualifying revenue losses}^{\text{ii}} + \text{Eligible COVID-19-related expenses}^{\text{iii}} - \text{Financial assistance received}^{\text{iv}} = X$$

... If X was greater than 0, the applicant may be awarded up to the total amount of X^v.

... If X was equal to or less than 0, the applicant will not receive an award.

Unsubmitted	Application has not yet been submitted. Applicant can continue to edit the application until it is submitted. All applications must be submitted by no later than November 24, 2020 at 11:59 PM EST.	Yes
Submitted	Application has been submitted. Applicant can no longer edit the application but can “view” the application.	Yes
Received	Application is currently in the review process.	Yes
Ineligible	<p>Applicant has not met one or more eligibility requirements.</p> <ul style="list-style-type: none"> • Is domiciled in Vermont. • Was operating on or before February 1, 2020. • Is considered a “billing provider” or has submitted a Peer Support & Program Pre-Approval Certification and received approval. • Is committed to maintaining participation in value-based payment initiatives, as applicable, through calendar year 2021, if already participating in calendar year 2020. Participation in a value-based payment initiative will not affect an entity’s award amount. • Agrees to the terms and conditions of the HCS grant. 	No
Non-Responsive	The reviewers noted either missing or erroneous information in your application or significant discrepancies between some application inputs and the supporting documentation needed for validation	Yes
Not Awarded	No additional unmet need was identified for the application period.	Yes
Approved	Application has established an unmet need for the application period.	Yes
Awarded	Applicant has been awarded a sum greater than \$0.	Yes
